Individually, 20 lawyers have been included in the guide, with Global Vice-Chair & ASEAN CEO Philip Jeyaretnam SC leading the pack as a Band 1 individual for Dispute Resolution: Litigation, and ranked in two other practice areas – Dispute Resolution: Arbitration, and Construction. Philip was described by sources as “a ferocious cross-examiner who out-thinks and out-fights his opponent”, with “a sharp mind and very skilled advocacy”.

Though many of the lawyers maintained their previous rankings, Senior Partner Joo Thye Tan achieved improved rankings, ascending to Band 2 for Projects & Energy.

Senior Partners Melanie Lim, who was singled out by clients as someone who “considers the issues, thinking outside of the box and finding solutions which suit us”, and Paul Wong, who “impressed with his depth of knowledge of construction law” were also ranked for the first time, in the areas of Real Estate and Construction respectively.
